1. Interested parties may submit bid for each vehicle individually in a sealed cover envelope latest by 12:00 noon 11.4.2017. The quotations and other relevant documents should be properly sealed. The envelope should be superscribed with "QUOTATION FOR DISPOSAL OF CONDEMNED VEHICLES". The same should be opened at 2.00Pm on the same day.
2. Cost of quotation amounting to Rs 100/-(non- refundable) is to be paid through internet banking only to the following Account:
(i) Name of A/c holder : Director, RIPANS
(ii) Name of Bank : Bank of Baroda, Aizawl
(iii) Account No. : 30800100002790
(iv) IFS Code : BARB0AIZWAL (fifth character is zero).Cyber receipt/E receipt should be submitted along with the quotation.
3. The disposal of the vehicles shall be strictly on "As is where is basis" and no guarantee or certificate of its worthness or its quality will be given by the Institute.
4. The condition of the vehicles can be inspected physically on any working days during office hours.
