BACKGROUND OF THE INSTITUTE

North East Region is admittedly on the most backward areas in the country. The backwardness is particularly marked in so far as health care is concerned. The reason are obvious - lack of infrastructure, physical and psychological distance from the heart of the country, communication bottle neck, lack of insufficient public consciousness, lack of attraction to private investment in health sectors in various reasons.

To overcome the problems the attention of the North Eastern Council was focused on the extreme need to develop adequate paramedical manpower to provide the much needed basic paramedical health care facilities in the health Institution of the North Eastern Regions. Accordingly the concept of the Regional Institute of Paramedical & Nursing Sciences finalized by the North Eastern Council in 1992-93 with the approval of the Government of India. All the allotted seats in different disciplines of the Institute is distributed as per quota fixed for to the beneficiary states. The beneficiary states of the Institute include:

- 1) Assam
- 2) Arunachal Pradesh
- 3) Manipur
- 4) Meghalaya
- 5) Mizoram
- 6) Nagaland
- 7) Sikkim
- 8) Tripura

The honourable Prime Minister of India had held a meeting on 16.10.2006 regarding the role of Ministry of DoNER and NEC in articulating the development needs of the North East. After detailed discussion, it was

decided among others, that Regional Institutions being funded and administered by North Eastern Council (NEC) should be transferred to the line ministry immediately. The NEC in its 53rd meeting held on 15th – 16th Nov, 2006 at New Delhi endorsed the Prime Minister's decision. It was concluded that with respect to NEC Regional Health Institutions, a committee under the chairmanship of His Excellency, Governor of Manipur would examine and recommend specific measures for retention of the regional characters and autonomy of these institutions. As recommended by the committee headed by Dr. S.S. Sidhu, His Excellency, Governor of Manipur, on transfer of NEC's Regional Health Institutions to the Ministry of Health & Family Welfare, Government of India recommendation was accepted and sanction of the competent authority was conveyed transferring the Regional Institute of Paramedical and Nursing Sciences (RIPANS), Aizawl, Mizoram, from the North Eastern Council (NEC), Shillong to the Ministry of Health & Family Welfare, Government of India w.e.f. 1st April, 2007 vide Ministry of Development of North Eastern Region letter No. 4/8/2006-DoNER(NEC-Pt-II) dated 29th March, 2007. From 1st April, 2007, the Ministry of Health & Family Welfare has taken over the control and management of the Institute with all its assets and liabilities. Following the transfer of the Institute to the line ministry budget allocation of the institute w.e.f. 1st April, 2007 is being provided by the Ministry.

AIM AND OBJECTIVES OF THE INSTITUTE

- 1) To create and provide an atmosphere and environment suitable for creative work in pursuit of knowledge and advanced learning in Paramedical and Nursing Sciences for the Beneficiary States viz. Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura.
- 2) To promote and conduct Research and Development in Paramedical and Nursing Sciences and complementary subjects thereof.
- 3) To foster a rigorous paramedical discipline, to stimulate a zest for creative work and to cultivate a spirit of intellectual collaboration amongst clinical/laboratory and scientific workers.
- 4) To hold and conduct examinations for Degree Courses, Diploma courses, Certificate courses or any other courses conducted by the Institute and to grant academic/professional distinction or title to persons who comply with the conditions and rules laid down by the different Councils.
- 5) To arrange lectures, meetings, seminars and symposia in pursuance of its academic/clinical work and for the diffusion of scientific knowledge.
- 6) To invite scientists actively engaged in creative activities to deliver lectures and participate in academic and clinical work.
- 7) To take such other steps as may be necessary for and conducive to the advancement of learning in Paramedical/Clinical and Nursing Sciences and for dissemination of knowledge in these sciences.

- 8) To establish, maintain, develop and promote educational links and close interaction, recognition, association, affiliation and cooperation with any Medical or Paramedical and Nursing Training, research and development bodies/Boards/Universities/ Government agencies and/or other institutions in India and abroad.
- 9) To establish, administer and manage hospitals/clinics/out-patient departments, hostels and other facilities required for the Institute.
- 10) To charge and collect fees from the students/trainees and for services rendered by the Institute in any form.
- 11) To receive grants-in-aid from the Central/State Governments and gifts, donations, benefactions, loans and subscriptions whether in cash or securities or any property either movable or immovable in furtherance of the objects of the Institute.
- 12) To acquire and hold any movable or immovable property required for furtherance of the objects of the Institutes.
- 13) To manage and invest funds of the Institute in such a manner as may be, from time to time, determined by the Government.
- 14) To frame rules and regulations for administration of the Institute and to frame regulations specifying the manner & conditions subject to which Pension and Provident Funds may be constituted or to fund appropriate Organization offering schemes like Pension, Provident Fund, Insurance etc for the benefit of the employees of the Institute.

- 15) To do all such lawful acts as are conducive or incidental for the attainment of the above objects.

- 16) To upgrade the courses, develop new courses as per need base of the North East Region and equip the Institute with better facilities in the endeavour to make the Institute a Centre of Academic Excellence.

- 17) To develop the RIPANS as a premier Institute in the North Eastern Region of the country for all disciplines.

INSTITUTE'S SET UP

ADMINISTRATIVE SET UP

Institute Administrative and Academic Set up is divided into two wings i.e. Administration & Establishment and Academic.

A) ADMINISTRATION & ESTABLISHMENT

In administrative & Establishment set up, there are two sections viz. Establishment and Account. In Establishment Section there is an Administrative Officer who is responsible to ensure smooth running of day to day functions of the administration and establishment while Account Section is headed by Finance & Accounts Officer responsible to prepare Five Year Plan and Annual Plan of the Institute covering the Academic Wing. The Officer is also responsible to maintain the financial discipline of the budgetary allocation of the Institute. Both the Administrative & Accounts Officers are responsible to offer free and frank advise from time to time to the Director of the Institute who is overall in-charge of the Institute for management and administration.

At the initial stage of the institute set up, very limited post were created by the Ministry of Home Affairs, Govt. of India, and no technical council norms in regards to staffing pattern of Academic Wing was followed. Every year, different technical council carried out the inspection of the institute's different courses and noted with observation that the institute should follow the staffing pattern prescribed by the different councils to run their respective courses. As the required post could not be created immediately, the institute has entertained some qualified faculty members to manage the class on contract basis with lumpsum remuneration. The inspect team recently conducted the annual inspection of Pharmacy Deptt. has addressed the need for creation of

regular post. The proposal for creation of new posts as per requirement of different technical council norms has been forwarded to the Ministry for consideration.

On taking over of administration and management by the Ministry of Health & Family Welfare, Govt.of India, New Delhi as per decision , existing M.O.A. (Constitution), Rules and Regulations and By-Laws of the Institute have been amended with the approval of the Ministry. Notification constituting the Board of Governors and the Executive Council of the Institute has been issued. However, reconstitution of various committees and sub-committees is yet to be notified as approval from the Ministry is till awaited.

1. **Terms of Office:** The terms of Office of the President and Members shall be co-terminus with the office they hold.

2. **Power and Function of the Board of Governors-**

- To appraise the budget, annual plans and five year plans of the Institute
- To make annual review of the functioning of the Institute
- To consider the implications of the Policy(s) adopted by the Council. It shall take final decision and ratify the matters referred to by the Executive Council.
- To consider and adopt the Audited Accounts of the Institute.

- e) To amend the Memorandum of Association, Rules and Regulations and the Bye-laws framed hereunder.
- f) Any other business with the permission of the President or as proposed hereinafter by a member may also be transacted in the meeting.

3. Meeting of the Board of Governors :

- a) The Board shall meet at least once in a year.
- b) Notice of the Meeting shall be served to the Members at least 14 days before the scheduled time as fixed by the President. A meeting with shorter notice may also be convened by the President in an emergent situation.
- c) Any accidental omission in the issue of notice to any member shall not invalidate the proceedings of the meeting.

4. The quorum for the meeting shall be at least seven members present and within half an hour of the time fixed for the meeting. If the quorum is not fulfilled, the meeting may be adjourned to such date, time and place. In such an adjourned meeting if the quorum is still not fulfilled by the members present thereat shall be quorum for the meeting to transact the business.

5. The meeting shall be presided over by the President and in case of his inability, the members present shall elect one amongst themselves to be the Chairman of the meeting to preside over the meeting and transact the business.

6. The President may, in the same manner as prescribed hereinabove, call in a special meeting whenever he thinks necessary or on a requisition in writing by not less than five members. Any valid requisition so made by the members shall state the objects of the meeting and shall be signed by all requisitionists.

7. Nothing in these Rules and Regulations shall prevent the President from exercising all the powers of the Board of Governors in case of emergencies for furtherance of the objects of the Institute and such action taken shall be reported in the next Board Meeting for ratification.
8. A record of the proceedings and resolutions of the business shall be signed by the President and the Member Secretary. A copy shall be circulated to all the members of the Board.

1. **Terms of Office of the Executive Council:** The term of Office of the Chairman and of the members, who are nominated to the Council in their individual capacity shall be co-terminus with the office they hold.

2. **Powers and Functions of the Executive Council:**
 - a) To supervise the overall administration and take decision on question of policy relating to the administration and management of the Institute.
 - b) To consider the budget estimates, approved and revised and supplementary if any, proposed by the Director and to appraise the Board and the Ministry of H&FW, Govt. of India.
 - c) To consider all proposals for new and additional expenditure beyond the powers delegated to the Director.
 - d) To consider the Audited Accounts and the Auditor's Report thereon and to take decision relating to them.
 - e) To review the financial position of the Institute from time to time through periodical control statements and to give advice thereon.
 - f) To review the work and progress of the Institute and to hold enquiries into the affair thereof.
 - g) To consider and approve the Academic, Scientific and Technical Programmes of the Institute.
 - h) To frame Bye-Laws, Rules and procedures for conduct of the affairs of the Institute including the service matters of the employees. (It will be appropriate that this power is vested with the Governing Council)
 - i) To enter into an agreement with Medical/ Paramedical/Nursing/ Research and Development with any Educational Institutions/ Boards/ Universities in India and abroad having objects wholly or partly similar to those of the Institute and to induct specialists from these Institutions to be made members on some Committee/ Sub-Committee in such a manner as considered expedient.

3. **Chairman of the Executive Council:** Where the Chairman of the Council is not available for presiding over the meeting of the Council, the members present shall elect one amongst them, other than the Director, as adhoc Chairman to preside over the meeting.

4. **Resolution of the Council:** All resolutions of the Council shall be adopted in a meeting duly convened. Provided that when it is not expedient to convene a meeting immediately and a decision is required to be taken urgently in the interest of the Institute, a resolution to this effect shall be passed by circulation.

5. **Vacancies:** Where a vacancy occurs in the office of the Council, other than the Director, through death, resignation or for any other reason, such vacancy shall be filled by the authority which appointed such member. Provided that no act or proceedings of the Council shall be invalid merely by reason of vacancy or of defect in the appointment of a person acting as failure to appoint a member against vacant office of a member of the Council or by reason of the fact that an appointing authority has failed to appoint a member.

In the event of a dispute as to whether the appointment of any member of the Council is valid or not, the decision of the Chairman of the Council shall be final.

6. **Meeting of the Executive Council:**
 - a) The Executive Council shall meet at least twice in a year or as considers expedient for the transaction of business of the Institute.
 - b) Notice of the Meeting shall be served to the Members at least 14 days before the scheduled time as fixed by the Chairman. A meeting with shorter notice may also be convened in an emergent condition.
 - c) The quorum of the meeting fixed for the meeting. If the quorum is not fulfilled, the meeting may be adjourned to such date time and place. In

such a adjourned meeting if the quorum is still not fulfilled by the members present there shall be no quorum for the meeting to transact the business.

- d) The Council may, in its meeting, transact any business other than those reserved for the Board of Governors for the Development, Management and Administration of the Institute.
- e) A record of the proceedings and resolutions of the business shall be signed by the Chairman and the Member Secretary. A copy shall be circulated to all the members of the Council.

7. Constitutions of other Committees:

The Executive Council shall have the power to constitute from time to time various Committees including Academic Committee, Finance Committee, Staff Selection & Departmental Promotion Committee and Purchase & Tender Committee. For such purposes, comprising of such number of members upon such terms lay down and any casual vacancy in the Committee may be filled in by the Chairman. The Meetings of these Committees shall be regulated either as per the terms of their appointment or as regulated amongst the members of the respective committees or as required by the Director of the Institute.

B) ACADEMIC WING

There are three Degree level Courses viz. B.Sc (Nursing), B.Pharm and B.Sc (MLT) and two Diploma Courses i.e. combined course of ECG & X-Ray – abbreviated form “Radio Imaging & Cardio-Instrumentation Technology (RICIT)” and Ophthalmic Technology where training of students admitted from different beneficiary states of North Eastern Region are imparted. The lone certificate course i.e Medical Laboratory Technology (Certificate Course) temporarily suspended due to inadequate strength of faculty members as two diploma course viz D.Pharm & MLT (D) offered by the Institute earlier has since been upgraded to degree level courses w.e.f 2004 Academic session.

For each course there is a Head of Department and under his/her guidance subordinate faculty members and other supported teaching and non-teaching staff are working. The head of department is accountable to ensure students training and conduct of annual and final examinations in consultation with Mizoram University and Mizoram State Council for Technical Education (MSCTE).

In addition there are three sections, viz. Training & Placement, Computer and Library of the Institute which are also attached to Academic Wing. The Director of the Institute is also the overall in-charge of the Academic Wing.

As a Regional Institute catering to the different Paramedical & Nursing Courses for the eight NE States, the different activities of the Institute within and outside the Campus and within and outside the State are varied and non-stoppable. From dawn to dusk, clinical duties of the trainee students keep going in different schedule and in different departments at the Civil Hospital and other leading Private Hospitals at Aizawl. Infrastructural development in terms of civil works, laboratory equipments and other aids for classroom teachings are the continual requirements as recommended by the different Statutory Councils with whom the Institute is affiliated to. Lack of posts mandatory for running the different courses offered by the Institute has to be supplemented from outsource agency.

In the midst of all the shortages and busy schedule, day to day administration needs strength to co-ordinate the different tasks. Further, to enable the smooth functioning and co-ordination of the different activities of the Institute, it is necessary that flow of fund should be regular – preferably release of fund at regular interval either quarterly or half-yearly.

On account of the handing over of the Institute to the line Ministry i.e. the Ministry of Health & Family Welfare, Govt. of India, all grant received are from the Ministry w.e.f. 1.4.07.

The tables given below show the position of fund receipt and the financial achievement of the Institute during the last 3 years i.e 2005-06, 06-07 & 07-08.

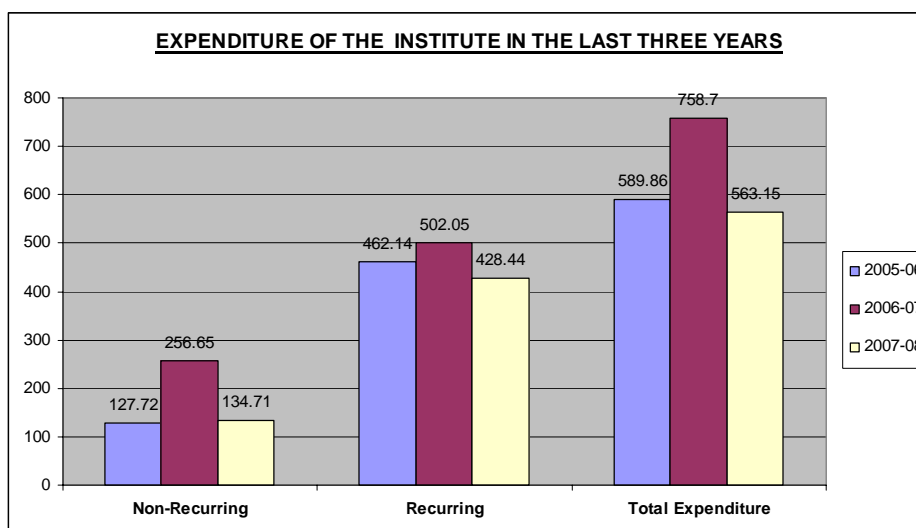

3. CORPUS FUND OF THE INSTITUTE:

The initial budget of the Corpus Fund as was incorporated and approved during the 1st BOG Meeting on 28th June 1996 was Rs.600.00 lakhs. However, with the inclusion of the State of Sikkim which is expected to contribute the amount of Rs.40.00 lakhs within a period of 4 years and lately the Pro-rata Admission Fees received by the Institute amounting to Rs. 25.00 lakhs, the total amount of Corpus Fund has come to Rs. 665.00 lakhs.

The Board of Trustees decided that the Corpus Fund may be kept intact and invested for the future upkeep of the Institute. Hence, the amount already raised from the different States including Sikkim (2 installments paid) & Pro-rata Fees, the amount of Rs.645.00 lakhs have been invested in Kisan Vikas Patra of the Head Post Office in Aizawl, Mizoram. The total amount invested is therefore, Rs.980.57 lakhs and the interest earned till 31st August 2008 is Rs. 335.57 lakhs.

4. AUDIT OF THE ACCOUNTS OF THE INSTITUTE:

The accounts of the Institute for the year 2007-08 has been audited by the Statutory Auditors M/s RKP Associates, Silchar during the period between 29th June to 5th July 2008 , however, the report is yet to be received.

In case of audit of the accounts and activities of the Institute by the A.G (Audit), audit of the period covering March 2003 upto December 2007 was conducted during January 2008. Fortunately, this has been made possible with the opening of the A.G Office in Aizawl during the latter half of 2007. Issue of Audit Certificate is awaited.

LAND AND BUILDINGS

WATER SUPPLY SYSTEM IN THE COMPLEX

One lakh gallon capacity underground water tank in the Complex has been constructed by State PWD few years back and public Health Engineering deptt. Aizawl has provided 4 water connections in the Complex to meet the day to day water requirement of the Hostellers and occupants of Staff quarters. But quantities of water supplied to the Complex by PHE is so inadequate that arrangement for purchase of water from private sources and carry to the Complex by Institute water truck has to be made to meet the day requirement of water for occupants of staff quarters and Boys' Hostels, leaving the water requirement of Girls' Hostel where 160 Hostellers provided accommodation unattended. To meet the day to day requirement of water for Girls' Hostellers, Institute has engaged 3 private water carrying contractors on payment basis which is eating a reasonable fund from the allocation.

However, as requested for through Hon'ble Chief Minister of Mizoram, it is expected that water crisis of the Complex would be solved by the PHE deptt. by ensuing the adequate supply of water to the Complex in near future.

FACILITIES PROVIDED TO THE STUDENTS OF BENEFICIARY STATES

A) HOSTEL FACILITIES:

Institute has provided Hostel facilities to the deserving students in and outside the Institute Campus. There are four Hostels (two each for Boys and Girls). Three Hostels are located in the Campus while one Girls' Hostel is located in the vicinity of Aizawl Civil Hospital of the Capital. Hostellers' strength in each Hostel is shown below:-

1)	Girls Hostel in Institute Complex	-	160

Considering the demand for Hostel accommodation, there is a proposal for construction of two more additional Hostels (Boys' & Girls') during the 11th Five year Plan of the Institute and the proposal has been incorporated in EPF memo for consideration and approval of the Ministry.

Preference for admission in Hostels:- First preference is given to those students in Hostel admission who come from outside the State as nominee of beneficiary States of North Eastern Region. After accommodating all the outside students who seek admission in Hostel next preference goes to the local students of the State of Mizoram provided seats are available in the Hostel after accommodating outside students.

Management of Hostels:- In each Hostel there is a Warden who is responsible for smooth management of respective Hostel. Above Wardens there is a Hostel Superintendent for both Boys' and Girls' who are responsible for over all supervision of Hostels. Hostels mess is managed/run by respective Hostel Mess Committee selected from the Hostellers on rotation basis.

Hostel Advisory Committee:- To keep vigilance over the activities of Hostellers of different Hostels, there is a Hostel Advisory Committee constituted under the Chairmanship of one Senior Faculty Member and all the Hostel Superintendents and Wardens are members of the Committee. Because of the strict implementation of Hostels Rules and Regulations by the Hostel Advisory Committee there is not a single incident of ragging/torture reported in the Hostels, since establishment and Hostellers irrespective of caste, creed and religion are maintaining good relation and integrity amongst themselves.

B) OTHER FACILITIES AVAILABLE IN THE CAMPUS:

1. **Library:** The Institute of RIPANS possesses a well-equipped and spacious library which provides different categories of books and journals for the students and staff. In addition to this, various daily national newspaper are also provided.
2. **Computer Facilities:** The Institute has a well-equipped centrally located Computer Centre in which the students can avail and acquaint themselves with the basic and necessary knowledge of the subject. Internet facilities are also provided in the Computer Centre for students and staff during working hours.
3. **Canteen:** To provide other facilities Staff Welfare Association of the Institute is running a Canteen where students and officials can have their refreshment even dinner and lunch at a concession prices. For convenient of the Hostellers and resident of staff quarters, a Grocery cum Stationer Canteen is opened and handed over to Private Party on annual contract basis. Canteen (Grocery cum Stationery) items are available at local market rates. In addition to these facilities, there is a PCO in the Complex managed by a Private Party for the convenient of the Hostellers and day scholars.

4. **Transportation:** Bus services are made available to the students and staff residing outside the Campus that ply from Aizawl to the Institute Campus and Vice-Versa. The service is available at the morning and afternoon hours and scheduled as per the class hours.

5. **Play Ground:** A sizeable playground for football, volleyball and basketball is available within the Campus itself.

TRAINING & PLACEMENT SECTION

The Training & Placement Section of RIPANS is mainly the Co-ordinating body of the Institute for the various courses conducted at RIPANS namely, the Degree Courses of B.Sc (Nursing), B.Pharmacy, B.Sc (MLT) and the Diploma Courses i.e. Ophthalmic Technology and X-Ray & ECG Technology, Combined Course (RICIT)

RIPANS is a centre for academic excellence in Paramedical & Nursing Sciences for students from the 8 North Eastern States who want to pursue a career in these technical disciplines. The State Government of the eight (8) beneficiary states have their own selection criteria on the basis of merit by which students are nominated for the respective courses of RIPANS. The intake capacity every year for the Degree Courses is 33, excluding Pharmacy which is 30. Some Degree Courses seats are filled up by direct interview and on merit basis against pro-rata contribution which are not filled up by respective state Governments.

The three degree Courses are affiliated provisionally by Mizoram University which is a Central University. Initially, the Affiliation of B.Sc (N) was to NEHU but when Mizoram University was established with head quarters at Aizawl the Affiliation with Mizoram University was done. Renewal and Extension of Provisional Affiliation of the 3 degree courses for the period 2007-2010 has been received. The B.Sc (N) Course is conducted in accordance with Indian Nursing Council (INC) Guidelines and Syllabus and is in conformity with INC directives the regulatory and statutory body. The B.Pharmacy course is conducted in conformity with the Pharmacy Council of India (PCI) and the All India Council for Technical Education (AICTE) which is the regulatory and

statutory bodies. The syllabus followed is as per PCI prescribed syllabus and stipulations. B.Sc. Medical Laboratory Technology Course is also conducted in conformity with the All India Council for Technical Education (AICTE) and Mizoram University who are regulatory and statutory bodies.

The Two Diploma Courses namely Ophthalmic Technology and X-Ray & ECG Technology are conducted on approval by AICTE and the examination is conducted by MSCTE & Higher & Technical Education Department of the State of Mizoram.

- (1) All matters related to payment of Affiliation fees to University of Mizoram, PCI, INC, AICTE & MSCTE.

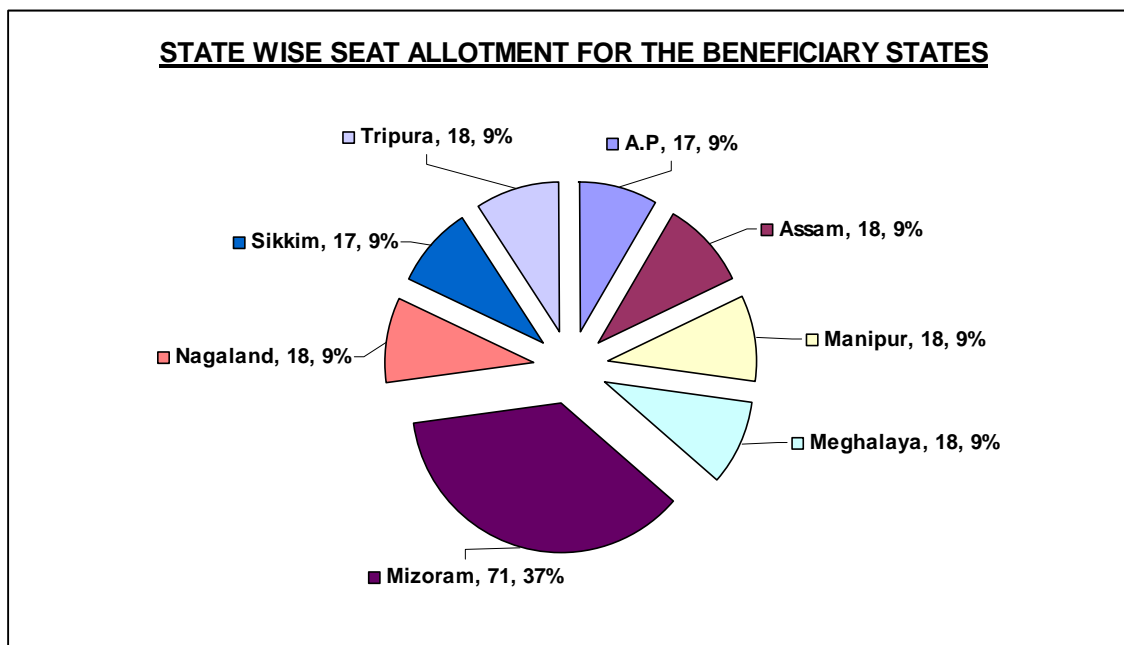
- (2) All matters pertaining to Admissions of students and information to the 8 constituent states namely Assam, Arunachal Pradesh, Tripura, Manipur, Sikkim, Nagaland, Meghalaya & Mizoram.
- (3) All matters pertaining to Stipend of Students, their Identity Cards, etc.
- (4) All matters pertaining to Inspection by various councils i.e. INC, PCI, AICTE and MSCTE and payment of Inspection fee.
- (5) Matters related to Examinations and correspondence relevant for Examinations.
- (6) The placement records of passed out students and are ex-alumni of RIPANS is also maintained as far as practicable by the section.

The Training & Placement Section thus functions as an amalgamating and co-ordinating body to synchronize the academic matters of the various courses conducted by the institute and converges the correspondence both incoming and outgoing of the various departments into a single channel thereby avoiding correspondence individually or department wise that may create confusions. It thus serves to streamline the academic activities of the institute and ensures uniformity. Initiation and starting of new courses and upgradation of existing courses is also done by this section.

The Training & Placement & Examination Cell is situated in the Administrative Block in the Directorate Office and is directly under the Director, RIPANS. The main aim and objective is to facilitate and ensure uniformity and stream lining and smooth functioning of all academic activities of the Institute.

Presently there are 5 courses conducted by the Institute.

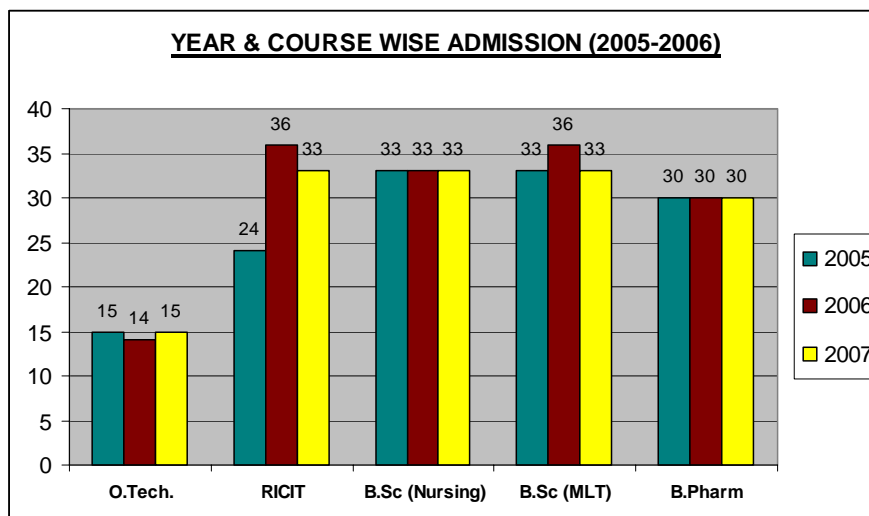

YEAR & COURSE WISE ADMISSION FOR THE YEAR 1996-2007

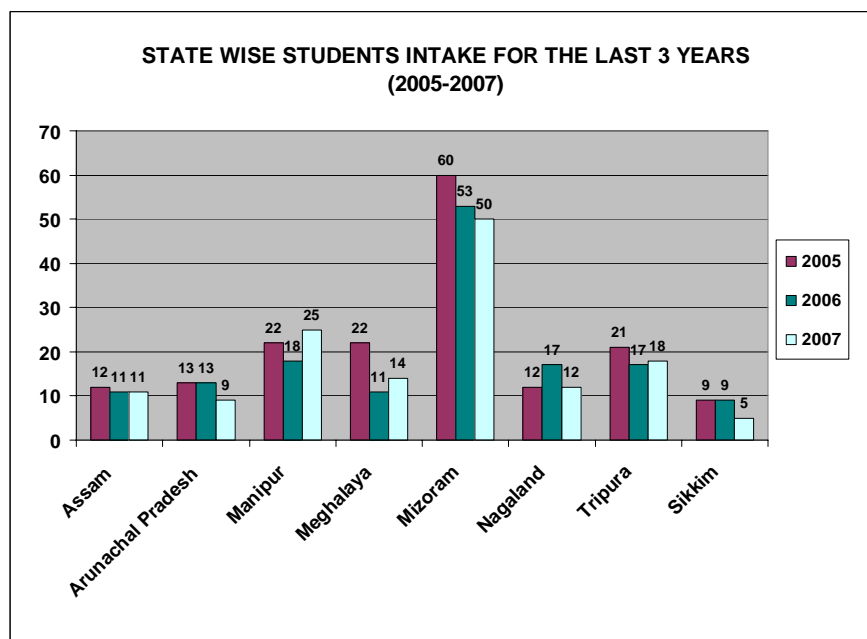

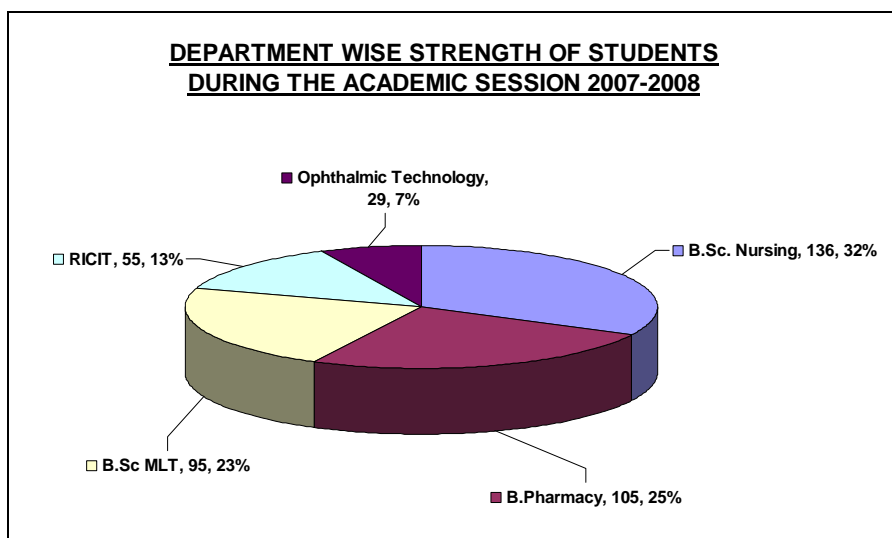

Brief Introduction:

The Bachelor of Science (Nursing) Degree programme was first introduced at the Institute in the year 1996 to become the first nursing college in the state of Mizoram. The course prepares the students to contribute to the development of nursing science through clinical and theory classes, which is based on scientific principles.

During the course of B.Sc(Nursing) at RIPANS, students are exposed to a variety of teaching methods all of which are designed to meet the requirement of Indian Nursing Council (INC) and to ensure that the students acquires a sound knowledge and skills in nursing.

Objectives:-

The following behavior objectives constitute the component of scholarship, practice, co-operation, collaboration, professionalization, and leadership.

Details about the Programme:

The B.Sc(Nursing) programme is a four year programme and the students have to appear for an examination at the end of each year up to 4th year. They are expected to have clinical experience both in hospitals and community settings.

The main activities are as follows:-

1. **Lecture:** These are designed to provide the student with the fundamentals subjects. Each class is held in the afternoon after clinical exposure in hospitals. Students are strictly expected to attend the class and must have 75% attendance in all the theory subjects.

2. **Clinical Experience:-** This provide the student with an opportunity to apply her or his knowledge and develop appropriate practical skills. They are provided in 4 or 5 numbers of students and practice nursing skills under supervision of Clinical Instructors. During clinical experience the students are expected to undertake case study, case presentation on selected patients and give nursing care to the patients under the guidance of nursing teachers. This help to develop skills and offer a platform for the students to participate fully in the learning process. The students must have 100% attendance in practical to be able to appear in the university examination. Time missed from clinical experience must be made up after completion of each year.

Statement of Recognition: - The course was affiliated to NEHU (now Mizoram University) on 21st may, 1998 and recognized by Indian Nursing Council on 5th March, 2001. Following this recognition, the students can register themselves in the State Nursing Council and practice Nursing anywhere in the country.

Admission Requirement :

- a. The minimum age requirement is 17 years
- b. The minimum qualification requirement shall be 10+2 of Hiher Secondary Examination or its equivalent with 50% or more aggregate in English, Physics, Chemistry and Biology. There is relaxation of 5% marks in case of ST/SC.

Method of Selection :-

The method of selection for admission of B.Sc (N) will depend on all the concerned states in the North East States as per seat allotment in the Institute. Each State of North Eastern Region is allotted 3 seats where as the Mizoram State is allotted 12 seats being host State which all together total of 33 seats per year.

Board of Under Graduates studies:

The Vice Chancellor of Mizoram University has constituted a Board of Undergraduate Studies in B.Sc (N) programme with the prominent members in the field for a period of three (3) years. The Principal is appointed for BOG as one of the members of Sikkim Manipal University of Health, Medical and Technological Sciences and NEHU Shillong.

INTRODUCTION

The Education of Pharmacy stepped in the State of Mizoram through the introduction of Diploma-in-Pharmacy Course (a two years course), by RIPANS (Regional Institute of Paramedical and Nursing Sciences) under NEC (North Eastern Council) in the year 1996. So, by the grace and sheet effort of the NEC, actual commencement of classes for the said course takes place from the year 1997. But later on, it was decided by the concerned authorities that Diploma-in-Pharmacy Course be suspended for a while and in its place Bachelor-in-Pharmacy (B.Pharm) Course be introduced. Therefore, Bachelor – in – Pharmacy Course was started from the year 2004 and the final year B.Pharm students admitted in the session 2004-2005 shall be coming out after the Final Examination under Mizoram University in the month of August/ September, 2008. The Bachelor-in-Pharmacy Course is approved and recognized by the regulatory bodies, viz ; PCI (Pharmacy Council of India) and AICTE (All India Council for Technical Education). The Institute is affiliated to Mizoram University.

The responsibilities of the Institute were taken over by Ministry of Health and Family Welfare, Govt. of India, from the NEC on 1st April, 2007 and onwards.

Pharmacy is one of the prime constituents of the Health-Care-System in the Country. The Profession of Pharmacy is chiefly concerned with drugs formulation, their manufacturing, quality control, dosing, handling, distribution, storage, etc. The important duties of the professional pharmacists are to provide to the general public information regarding proper usage and handling of drugs; and drug treatment regimen in order to achieve a better

Health-Care-System in the Country. Pharmacists are the person who dispenses quality and standard medications to the people, and “Drugs” stand just behind the Food Articles, nowadays. Pharmacists are also concerned with providing information regarding marketing of drugs, drug products to the Registered Medical Practitioner as well as Medical Stores.

Biotechnological Research for the Therapeutic Industry has added a dynamic potential to the service of Pharmacists, Industrial Pharmacists, and Research and Development Pharmacists.

In Modern days, Professional Pharmacists have a great and bright future ahead of them as various career opportunities and scopes are available to them. Let us always remember that it is mainly through the hard works of the Professional Pharmacists that the Country can have a better quality and safer drugs, and a better awareness regarding drugs among the general public; and thereby a better Health-Care-System for all.

ADMISSION CRITERIA:

Minimum qualification for admission in Bachelor-in-Pharmacy (B.Pharm) Course is a 10+2 passed in Sciences Examination with Physics and Chemistry as compulsory subjects along with the subjects of Mathematics or Biology.

DURATION OF COURSE:

The duration of Bachelor-in-Pharmacy Course shall be four (4) Academic years, with each Academic years spreading over a period of not less than one hundred and eighty (180) days; in addition to this, the Candidate shall undergo a one month Industrial Training in 3rd year B.Pharm.

FACILITIES AVAILABLE IN THE DEPARTMENT:

1. **Library:** Pharmacy Department in RIPANS has a separate library within a premise of the Department itself in order to provide a better accessibility and convenience to the students.
2. **Computer Facilities:** The Institute also provides a well-equipped centrally located Computer Centre which the students can avail and acquaint themselves with the basic and necessary knowledge of the subject.
3. **Girls' Common Room:** A newly constructed Girls' Common Room is provided in the Pharmacy Department. The students may access this Common Room in their leisure times during the working days.

MONTH OF UNIVERSITY DEGREE EXAMINATION:

It was decided by the Mizoram University that the Final Examination shall be conducted in the month of August of every year. As the Bachelor-in-Pharmacy (B.Pharm), a four years integrated course was introduced in RIPANS in 2004; the fourth Year B. Pharm will be appearing Final Examination under Mizoram University in the month of August- September, 2008.

FUTURE PROSPECTS OF THE COURSE:

India is having vast and growing Pharmaceutical Industries having annual turnover of more than Rs.4200 crores, with annual growth rate of about 13.7% Indian Pharmaceutical Industry is undergoing a fast and rapid transformation due to innovative research and the wave of globalization of trade. India is 4th in the world in terms of Volume production of Pharmaceuticals and about 7% of the Worlds Drugs are manufactured in India. On the other hand, the ever increasing population needs a better and readily available Health Care. All these factors reflect that Health Care System in India has to go a long way on which Pharmacists are playing a vital role. The role of Pharmacists can be emphasized as follows:-

For promotion of Research study in the field of Traditional Indian System of Medicines, North Eastern Council (NEC), sanctioned Rs.50.00 lakhs i.e. Grant-in-aid Rs.45.00 lakhs and Bank Loan Rs.5.00 lakhs, and released the fund through the State of Mizoram during 2005-2006.

A committee was constituted to monitor the implementation of the project scheme. The committee was under the Chairmanship of the then Governor of Mizoram, His Excellency Shri. A.R. Kohli and the State Government and Mizoram University officials as members and Director of the Institute act as the Member Secretary.

The original X-Ray department and ECG technology departments in RIPANS were amalgamated to form the Department of RICIT. The course is a 2 year Diploma course. The existing courses were also upgraded and training is now being offered in the following areas:

3. CT Scan
4. Ultrasonography
5. MRI
6. Radiotherapy
7. ECG
8. Echocardiography
9. Holter
10. Treadmill

AIMS & OBJECTIVES:

The main aim of this course is to give the students adequate working knowledge of X-Ray and ECG and to expose them to the other above mentioned modalities. This is a job-oriented training which helps them to be easily absorbed in the Government or Private health care sectors. Besides for those who would desire to pursue higher education in CT technology or MR technology etc. they would have a working knowledge of them. Practical exposure is given to the in the various modalities mentioned above in different types and different brands of equipments. Over and above, exposure training is

organized at Guwahati where the emphasis is being particularly in higher end diagnostic modalities and Radiotherapy.

JOB PROSPECT:

The combined course offers innumerable job opportunities from small X-Ray clinics to large diagnostic centres and hospitals. Besides, adequate employment opportunities are also available in the Government. For the enterprising , it also provides the avenue of collaborating with practicing Physicians and Radiologist to open their own centres for X-Ray / ECG etc. For those who wish to pursue higher studies they can go for BSc in Radio-Imaging Technology or for training in particular high end modalities like CT Scan, MRI and so on.

Exposure Training:

Second Year student completed their exposure training of one month at GNRC, Guwahati from 15th May to 15th June 2007. In the coming academic year the exposure training is to be done at NEIGHRIMS Shillong. For this purpose senior faculty of this department had visited the said Institute to make necessary arrangement and communication is also done.

Introduction

The Ophthalmic Technology is a Diploma Course of 2 years duration offered by RIPANS since 1996. It is recognized by the AICTE and examinations are conducted by the Mizoram State Council for Technical Education (MSCTE).

Report of Academic Year 2007 – 2008

1. The Academic session of the course starts in September each year. During the year under report, the department had 15 students in the 2nd Year (Batch of 2005 – 2007), 14 students in the 1st year (Batch of 2006 – 2008) and 15 students in the new admission in the month of September 2007 (Batch of 2007 – 2009) from the beneficiary state of North East Region.
2. Theory classes, practical and clinical postings at Civil Hospital, Aizawl is being conducted as per the Academic calendar.
3. **Exposure Training:** The 2nd Year students (Batch of 2006 – 2008) were sent for an exposure training at Sri Sankardev Netralaya, Guwahati for a period of one month in March, 2008 accompanied by one faculty member and successfully completed the exposure.
4. **School eye clinic:** In collaboration with the NSS Unit of Government Zirtiri Residential Science College, Ramthar Veng, Aizawl, Mizoram, the Department of Ophthalmic Technology, RIPANS, organized an Eye Camp/Clinic between 3rd and 5th July, 2007, in partial fulfillment of the Curriculum set for the Ophthalmic Technology Diploma Course.

The team, comprising of all the staff of Ophthalmic Technology Department, RIPANS and all the 2nd year students proceeded to the Govt. Zirtiri Residential Science College on 3rd July, 2007 by the Institute bus. The team was warmly welcomed by the Principal and Faculty of the College. A brief inauguration was held in which short speeches were delivered by the Principal, Govt. Zirtiri Residential Science College, Dr. R. Lalrinzuali, HOD O.Tech, RIPANS and by Mr. Zira, Lecturer, Govt. Zirtiri Residential Science College. The Eye Clinic was started immediately after the inauguration.

On all the three days of the clinic, health talks on various topics relating to Eye Care were given by each of the 2nd year Ophthalmic Technology students highlighted by charts, models and other teaching aids.

All the students and staff of the college were examined. Registration, visual acuity, colour vision, retinoscopy and refraction were done.

1. Introduction of Computer Courses: Theory and practical classes in Computer Courses have been conducted for the students of B.Sc(Nursing) and B.Pharm since the Indian Nursing Council and the Pharmacy Council of India have introduced Computer course as a compulsory subject in its curriculum for the B.Sc. 2. Up-gradation of infrastructure for academic activities of the Institute:

Institute's old Desktop Computers have been replaced with brand new 45 sets of Desktop Computers with latest models where 30 nos are installed at Computer Centre and the rest are installed at different section of the Institute. Computer Training of students is running smoothly since new Desktop Computers were installed in the Computer Centre. There is also a proposal for procurement of additional Desktop Computers for upgradation of Computer Lab to accommodate all students in their respective Computer Practical classes.

(ii) Introduction of Electronic Visual Class Room:

The Institute has newly created five Electronic Visual Class Rooms for each department viz. Pharmacy Deptt., Nursing Deptt., MLT Deptt., RICIT Deptt. & OT Deptt., where the rooms are equipped with presentation tools like Interactive Board, Visualizer, Projector and Sound Systems, which is helping the teachers and the students for advanced interactive teaching and for seminar & presentation as well.

(iii) Up-gradation of Conference Room with Boardroom Integration and Video-Conferencing equipments:

Conference Room was upgraded with well-equipped Boardroom Integration and Video-Conferencing facilities which is now completed and fully functioning.

3. Internet Connection in the Institute:

Internet connection has been provided in the Computer Laboratory for the students and the faculties. Research cum Instrumentation Room in Pharmacy

Department and Training & Placement Cell in Establishment section were also provided with Internet connection to help the staff for collecting information.

A high speed internet MPLS/VPN connection, supporting 512kbps (*Dedicated Internet Bandwidth*) was established for the Institute which was subscribed from the internet service provider M/s Tulip IT Services, New Delhi.

Due to lack of networking facilities in the Institute, sharing of Internet facilities to different sections is a problem. Hence, proposal has been made for up-gradation of Campus Networking in the Institute.

4. Renovation & Up-gradation of Computer Laboratory:

The Computer Laboratory was upgraded to accommodate 35 Students and required Desktop Computers for training of students have been procured and installed.

1. **Shri. H. Lalhlemawia, Senior Lecturer.** He is undergoing Ph.D. study under the guidance of Dr. S.C. Mandal, Reader, Department of Pharmaceutical Technology of Jadavpur University Kolkata and Dr BB Bhattacharjee, Head, Deptt of Pharmacy RIPANS in the topic of “Exploration of Anti Diabetic potential of Mallotus Roxburghianus found in the State of Mizoram.”

2. **Smti. T. C. Lalhriatpuii, Lecturer.** She is undergoing Ph.D. study under the guidance of Dr. S.K. Ghosh, Reader, Department of Pharmaceutical Services of Dibrugarh University, Assam in the topic of”Phyto chemical and pharmacological screening of selected Medicinal plants found in the State of Mizoram.”

iii) **Shri. Firdoos Jaman, Demonstrator, Ophthalmic Technology Deptt.** B. Optometry Course at Martin Luther Christian University, KJPA Conference Centre, Central Ward, Shillong, Meghalaya state from 2007.

PROJECT UNDER INDIAN SYSTEM OF MEDICINES

With the Financial Assistance of North Eastern Council, Shillong under Ministry of Development of North Eastern Region (DoNER) Govt. of India, the Institute has taken up the following project works under Indian System of Medicines and completed.

(1) Enabling Green Gardens (Therapeutic Garden)

The foundation stone of the Project “Enabling Green Gardens” (Therapeutic) was laid by the then H.E. the Governor of Mizoram Shri. A.R. Kohli on 10th February, 2006 in the RIPANS Complex. The project works was entrusted to Mission Matrix Maveen, Jagdish Prasad Saxena Memorial Society a New Delhi based consultancy firm and completed recently. Gardens will be opened for public after inauguration. This is the first kind of Therapeutic Garden in the North East States : Important features “Enabling greens stand the commitment of functional fitness to the people who are at disadvantage on performing activities of daily living, in a most relaxed and habit forming way. This will go manifold to advocate that acquiring physical, mental, psychological, spiritual and religious growth is an essential part of human development and ecstasy.”

(2) Research Laboratory in Pharmacy deptt. of the Institute.

Institute has developed a Research Laboratory in Pharmacy deptt. by purchasing the required equipments and apparatus. The main object of Research Laboratory is to undertake research study and analysis of medicinal plants locally available. Under this project, the following areas of investigation are covered :-

1. Investigation of phytochemical constituents.
2. Screening of Pharmacological activities like antimicrobial, anti diabetes, anti-ulcer, anti-inflammatory and analgesics.

Research works are carried out on regular basis on selected plants and processed. Isolation and purification of chemical constituents and its anti-diabetic properties of ***Mallotus roxburghianus*** have been completed and sent to International Research Journal for publication. Also the photochemical and pharmacological screening of ***Stephania glandulifera*** for its antimicrobial activities, ***Melothria umbellata***, ***Thumbergia grandiflora***, ***Cissus discolor*** and ***Plumetia acumina*** for its analgesic and anti-inflammatory activities are under process. At the same time antiulcer drugs screening is taken simultaneously.

VISION PLAN

1. Upgradation of Diploma Level Course to Degree Course.

There are 3 Degree Level Courses viz (a) B.Sc(N) (b) B. Pharm (c) B.MLT and in addition 2 Diploma Level Courses i.e. Combined Course of X-Ray & ECG Radio Imaging and Cardiac Instrumentation technology (RICIT) and Ophthalmic Technology. Criteria for admission in both Degree and Diploma Level Courses are 10+2 Science. Seats for Degree and Diploma Courses allotted to North East beneficiary states it has been observed since last few years that beneficiary states failed to nominate candidates even half of their allotted quota in Diploma Level courses. General perception is that the students who passed 10+2 Science prefer to study in Degree Courses for which beneficiary states are finding difficulties to fill up their allotted quota. The proposal for upgradation of 2 Diploma Courses to Degree Courses has already been approved by the Institute's Executive Council meeting held on 3.1.2008 at New Delhi.

Due to non-availability of sufficient classroom in the present infrastructure and lack of strength of faculty members, the proposal for introduction of M.Sc (Nursing) course has been differed to Academic Year 2010-11. Within this period it is expected that new Academic Building-III will come up and required manpower to run the course will be available in hand and the proposal for creation of new post as per Technical council Norms had been submitted to Health Ministry. As regards, to construction of Academic Building-III the State PWD has already prepared infrastructural designed of the building and as soon as plan & estimate is prepared the same will be forwarded to Health Ministry for approval of EFC.

2. **Introduction of M.Sc (Nursing) Course.**

Institute has proposed to introduce M.Sc (Nursing) course from the next Academic Session provided Nursing Council of India grant permission to open the proposed course. Essentiality certificate from the state Health & Family Welfare Department has already been obtained and provisional affiliation from Mizoram University has been received from the University authority. Approval from Executive Council of RIPANS has already obtained. This course will be introduced during 2010-2011 as present infrastructural facilities and manpower does not permit to introduce the course immediately.

3. **Introduction of Bachelor of Physio Therapy Course.**

There is also a proposal to introduce the course of Bachelor of Physiotherapy in the Institute in future considering the demand for this Course. However, immediate introduction of this Course may not be possible because of dearth of teaching faculty members and class rooms etc. It is expected that when the Academic Block-III building construction is completed action for introduction of this course will be taken immediately. This has an approval of Executive Council of the Institute. The existing Diploma Courses viz O. Tech, RICIT proposed for upgradation to Degree level Course will be introduced during Academic Session 2010-11 provided infrastructure facilities and required number of faculty members are available.

In addition to the introduction of above courses the Institute is planning to introduce some more Diploma & Degree Courses in future. The proposed courses are:-

- 1) Bachelor in Optometry
- 2) Bachelor in Rehabilitation
- 3) Bachelor in Radiology
- 4) Diploma in Optometry
- 5) Diploma in MLT.

The introduction of above courses in the Institute in future has also been approved in the meeting convened by the Director General of Health Services, Govt. of India, New Delhi on 31.7.2008.
